

## Commissioning brief - April 2024

## Short film production: Two Hands / Dewdhorn / Deux Mains / Daou Zorn

The FylmK contemporary short film funding scheme has been running in partnership with the Cornish Language Office since 2019 with initial titles made available to a wide demographic through BBC iPlayer. This builds on a strong tradition of previous short form work in Kernewek prior to that through the Govyn Kernewek award, some of which can be viewed via Tyskennow Kernow.

The broadcasters in Brittany have been commissioning short films for over a decade. Nine short films have been produced et broadcast since the beginning of this scheme funded by the Regional Council of Brittany and the broadcasters.

Thanks to additional funding through the UK Shared Prosperity Fund and a partnership with the Breton broadcasters, we are pleased to offer a new short film commission that encourages work in Kernewek and Breton.

This commission has been set up with the aim to:

- develop the range of films available in the Cornish and Breton languages
- develop the skills and expertise to produce film in Cornish and Breton
- support Cornish and Breton filmmaking talent
- produce shared screen experiences for Cornish and Breton audiences
- nurture collaboration between these close Celtic nations

Screen Cornwall, working with Cornwall Council's Cornish Language Office, has developed a clear and supportive methodology for working with filmmakers creating work in Kernewek for the first time. Once scripts are signed off in English, a translation is provided as well as voice notes of the language so the director and actors can hear how it should sound. We also aim to provide Cornish language pronunciation support on set as far as practically possible. Editing is done with English subtitles in place and credits are also translated.

The Breton Language Office can provide Breton language support for translation from French to Breton. The Office can also help filmmakers in finding trained Breton speakers to work on the projects.

- Script in standard industry format (Celtx has a free scriptwriting level if you don't already have a paid package). We strongly recommend that this is a developed piece and not a first draft.
- Short pitch deck including logline, synopsis, team biographies, visual moodboard and other creative details you are able to share at this stage.
- Budget
- Timeline of key dates (pre-production, production and post-production) with some contingency built in

Interviews with shortlisted teams will be held via Zoom on Monday 3<sup>rd</sup> or Tuesday 4<sup>th</sup> June.

## **General terms & conditions:**

- 1. All productions must be set in and shot in Cornwall and the Isles of Scilly and/or Brittany, with as many local cast & crew involved as possible.
- 2. All quoted budgets are inclusive of VAT/TVA. All commissioned producers must pay everyone who is not currently in full-time education the Real Living Wage or Equity Minimum for Actors, or French equivalents. Scripts submitted should be achievable for the budgets specified and have some contingency built in.
- 3. Scripted production commissions should aim to include at least one crew trainee opportunity to be offered to a pre-selected pool of early stage crew through Screen Cornwall. Further traineeships may be offered to those in education on an unpaid basis as necessary.
- 4. Scripted production commissions should contain content that would achieve no more than a 12A BBFC certificate.
- 5. Any project that involves under 18s should demonstrate consideration of appropriate safeguarding and child licencing requirements from a practical production and budgeting perspective.
- 6. Producers will be required to collect and share equality, diversity and inclusion data for cast and crew using Screen Cornwall's template. This data will be shared with funders.
- 7. Producers will be required to complete a carbon action plan with support from Screen Cornwall and commit to at least three carbon reducing approaches in production, as well as reporting final carbon footprint.
- 8. All commissions will be issued with a standard deliverables list that will include audience accessibility elements such as subtitles and audio description files.
- 9. All short form commissions will grant a non-exclusive licence to Screen Cornwall for 24 months from either delivery or the end of the festival run, whichever appropriate, as well as the broadcast & digital licence for French territories to the Breton broadcasters.
- 10. Successful teams will be required to supply information for publicity on announcement of the commissions, during production and through the festivals and distribution stage.
